CONSULTING SERVICES FOR COMMUNITY DEVELOPMENT OFFICER (CDO)

REQUEST FOR EXPRESSIONS OF INTEREST

The Government of Grenada (GOG) has received financing from the Caribbean Development Bank (CDB) towards the cost of the Climate Smart Agriculture and Rural Enterprise Programme (SAEP) Phase II and the Basic Needs Trust Fund (BNTF) Programme and intends to apply a portion of the proceeds of this financing to eligible payments under a contract for which this invitation is issued. Payments by CDB will be made only at the request of GOG and upon approval by CDB, and will be subject in all respects to the terms and conditions of the Financing Agreement. The Financing Agreement prohibits withdrawal from the financing account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of CDB, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than GOG shall derive any rights from the Financing Agreement or have any claim to the proceeds of the Financing.

The Ministry of Economic Development, Planning & Cooperatives, the Implementing Agency (IA), now wishes to engage the services of a **Community Development Officer (CDO)** on a contract basis to support the implementation of project activities.

The objective of the consultancy is to promote inclusive community participation and strengthen local capacity in the planning, implementation, and management of the Project climate-smart infrastructure and training and capacity building technical assistance. The CDO will engage rural communities, including women, youth, and small farmers, to ensure equitable access, social accountability, and sustainable management of Programme-supported facilities.

The duration of the assignment is expected to be for a period of **forty-eight (48) months** from the date of contract signing, covering the full implementation period of the Programme.

The Ministry of Economic Development, Planning & Cooperatives now invites interested eligible individual consultants to submit Expressions of Interest indicating qualifications and experience to provide this consultancy services.

Individuals shall be eligible to participate if:

- (a) the persons are citizens or *bona fide* residents of an eligible country; and
- (b) in all cases, the individual has no arrangement and undertakes not to make any arrangements, whereby any substantial part of the net profits or other tangible benefits of the contract will accrue or be paid to a person not a citizen or bona fide resident of an eligible country.

Eligible countries are member countries of CDB. Consultants are advised to review the detailed eligibility criteria detailed in Section 4 and conflict of interest provisions in Section 5 of the Procurement Procedures for Projects Financed by CDB (January, 2021), as published on CDB's website.

In the assessment of submissions, consideration will be given to Consultant's qualifications and experience on similar assignments.

All information must be submitted in English. Further information may be obtained from the first address below between 8:00 am and 4:00 pm (Grenada time), Monday to Friday. The full details of the specific Scope of Works/Term of Reference are available on <https://procurement.gov.gd/> or can be requested at email address 1 below, or can be downloaded from the notice published on the CDB's website.

One hard copy of the Expressions of Interest must be received at the first address below no later than 4:00pm (Grenada time) on **Friday June 26, 2026** and one electronic copy must be sent simultaneously to CDB at the second address below. The sealed envelope containing each submission should include the name and address of the applicant and shall be clearly marked "**Expression of Interest – Consulting Services for Community Development Officer (CDO)**"

Following the assessment of submissions, the most technically capable and appropriately experienced applicant will be invited to negotiate a contract to provide the consultancy services. GOG reserves the right to accept or reject late applications or to cancel the present invitation partially or in its entirety. It will not be bound to assign any reason for not engaging the services of any applicant and will not defray any costs incurred by any applicant in the preparation and submission of Expressions of Interest.
